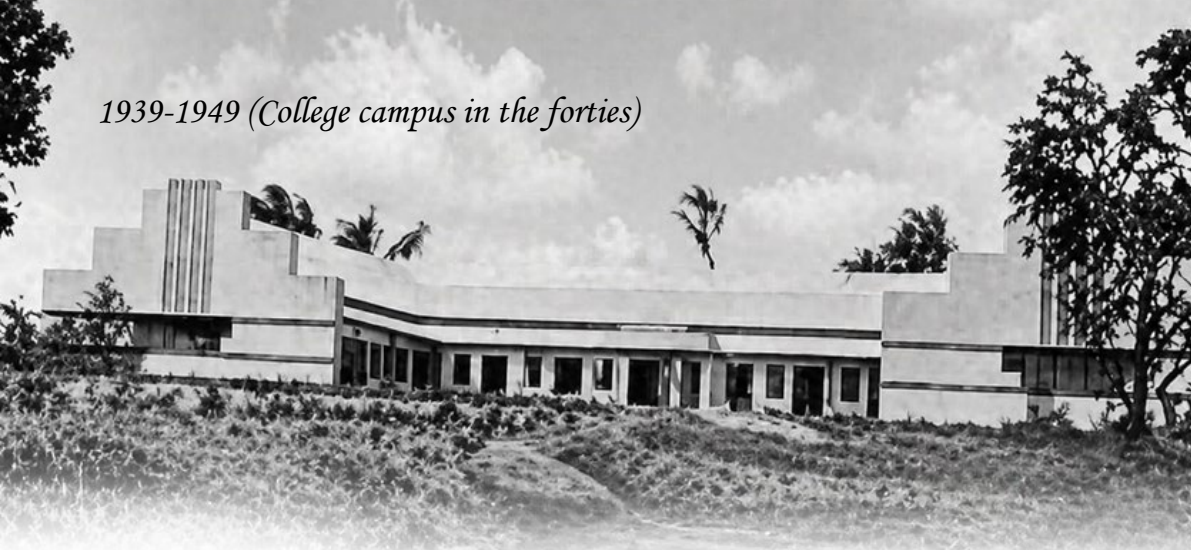

UNIVERSITY PROFILE

Gurucharan University, Silchar, is a newly established State University created by upgrading the historic Gurucharan College under Assam Act No. LVII of 2023. The institution carries forward a rich academic legacy that began with the establishment of Gurucharan College on 15 July 1935, which has long been recognised as one of the premier centres of higher education in the Barak Valley region of Assam. Over the decades, the institution has earned a distinguished reputation for academic excellence, intellectual growth, and its significant contribution to higher education in eastern India.

The establishment of the college was inspired by the farsighted vision of Bishnu Charan Dey Purkayastha of the Department of Education, Government of Assam. The initiative received generous support from Kiransashi Nag, the devoted wife of Gurucharan Nag, whose financial contribution in 1934 played a crucial role in founding the institution. In recognition of this contribution, the college was named Gurucharan College. The first Principal of the institution was Arun Kumar Chanda, a distinguished barrister-at-law, who played a key role in shaping its early academic development.

Initially, the college functioned in a bungalow at Rongpur on the bank of the Barak river. Due to riverbank erosion, the institution was temporarily shifted to the Silchar Normal School campus before acquiring its permanent campus at the present location.

Over the years, the college expanded its academic programmes and infrastructure, gradually establishing itself as a prominent centre of learning in the region.

Historically, Gurucharan College was affiliated with Calcutta University and later with Gauhati University. With the establishment of Assam University, Silchar, in 1994, the college became affiliated with Assam University. The institution offers programmes under the faculty of Sciences, faculty of Languages, faculty of Humanities and Social Sciences, and faculty of Commerce and Management, and has introduced several career-ori-

ented and value-added courses to enhance students' skills and employability.

The institution has received notable academic recognition, including NAAC 'A' Grade accreditation with CGPA 3.11 in its second cycle and the status of College with Potential for Excellence (CPE) by the University Grants Commission (UGC). The campus is equipped with modern facilities such as a well-stocked library with INFLIBNET access, a Central Computer Laboratory, Bioinformatics Centre, Biotech Hub, and an Anthropological Museum, along with hostels, playgrounds, health centre, auditorium, and other student support services.

The transformation of Gurucharan College into Gurucharan University marks a significant milestone in its academic journey. As a State University, it aims to promote higher education, interdisciplinary learning, and advanced research in alignment with the principles of the National Education Policy (NEP) 2020. The introduction of the Ph.D., FYIMP and Two-Year PG programmes from the academic session 2026–27, offered for the first time under the University framework, represents an important step toward strengthening higher education, research and innovation in the region.

Gurucharan University is located in Silchar, the headquarters of the Barak Valley region of Assam, a city known for its cultural heritage and scenic beauty. The region is also famous for its lush tea estates, which contribute significantly to the local economy.

With its proud legacy and renewed vision as a State University, Gurucharan University is committed to advancing knowledge, fostering research, and contributing to the educational and socio-economic development of the region and the nation.

The Gurucharan University Act, 2023 (Assam Act No. LVII of 2023) provides for several statutory authorities responsible for governing and administering the various functions of the University. These authorities ensure effective academic, administrative, and financial management of the University. The important statutory bodies of the University include the Court, Executive Council, Academic Council, Finance Committee, College Development Council, and other authorities constituted as per the provisions of the Act and the statutes of the University.

ABOUT THE DEPARTMENT

The Department of Anthropology of Gurucharan University (erstwhile Gurucharan College) began its modest journey in July 1965 and became fully functional in November 1965 under the leadership of Dr. Amitava Das Gupta, the Founder Head of the Department. Established as one of the pioneering departments in the field of Anthropology in Southern Assam, the department has played an important role in promoting anthropological studies and research in the region. The Honours Course in Anthropology was introduced in 1986, expanding the academic opportunities for students interested in the discipline. At present, the department has four faculty members and one laboratory attendant, while one supporting staff position remains vacant due to superannuation. The department publishes an annual journal titled *Mankind* (ISSN: 2278-9235), which has been in continuous publication since 2005, providing a platform for academic discussions and research in Anthropology. In addition, the department established an Anthropology Museum in 2007, which serves as a valuable learning resource for students and researchers. The Department offers Higher Secondary and Undergraduate Degree courses for students from both Science and Arts streams. In line with the principles of the New Education Policy (NEP 2020), the department promotes interdisciplinary learning and provides academic exposure to students from Science, Arts, and Commerce streams, encouraging a holistic understanding of human societies and cultures. The Department regularly organizes national webinars, invited talks, and extension activities from time to time to promote academic exchange, community engagement, and holistic learning among students.

ABOUT THE DEPARTMENT

The Department of Biotechnology at Gurucharan University, Silchar, was established in 2007. It is a premier centre for biological sciences in the Barak Valley, known for its Institutional Biotech Hub (established in 2011) and Bioinformatics Centre. The department offers a flagship Biotechnology program covering core areas like Molecular Biology, Genetics, and Microbiology. Students benefit from a research-oriented environment with active workshops and hands-on training programmes. The department publishes the annual journal *BIOTECH* (ISSN: 2230-9098) and an annual newsletter *BIOLETTERS*, focussing on recent advances in the field of Biotechnology. It also offers advanced academic programs, including Four year Integrated Master's degree course, M.Sc. and Ph.D. degrees, focusing on frontier areas like Bioinformatics, and Medical Biotechnology, Microbiology and Plant Biotechnology.

The Department had a very humble beginning. During its inception, Biology as a subject was introduced in I.Sc. course with only 75 students in the academic session 1949-1950. Dr. B. Bhattacharjee, a local Physician, rendered his service on honorary basis as Lecturer of Biology. Thereafter, Botany as a Pass-subject was introduced in B.Sc. Course during the academic session 1960-61.

After a decade, Botany as Honours-subject was introduced in B.Sc. Course during 1970-71 session. Over the years, it has become a full fledged department with undergraduate courses. The department is going to flourish further with the introduction of Post graduate courses and doctoral research in Botany in the near future. Our vision is to explore but not to exploit the plant world. Our vision is also to be a centre of excellence particularly in Plant Taxonomy and Biosystematics, Microbial Sciences, Plant Biochemistry and field work based Ecological studies.

The Department of Chemistry at Gurucharan University (erstwhile Gurucharan College) has a rich and inspiring history marked by dedication, perseverance, and academic excellence. Its origins are closely linked with the vision of the founder Principal, the late A.K. Chanda. A milestone was achieved in 1954 with the introduction of the B.Sc. course in Physics, Chemistry, and Mathematics. With the arrival of distinguished teachers—particularly Prof. B.K. Sinha, who served as HOD for 35 years. In 1962, the department introduced Honours courses, marking a significant advancement in academic offerings. During the late 1960s and early 1970s, the department witnessed its 'golden phase,' with a full complement of eight lecturers and two demonstrators. With a glorious past, a resilient present, and a hopeful future, the Department of Chemistry at Gurucharan University proudly carries forward its tradition of excellence and service to higher education.

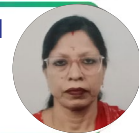

ABOUT THE DEPARTMENT

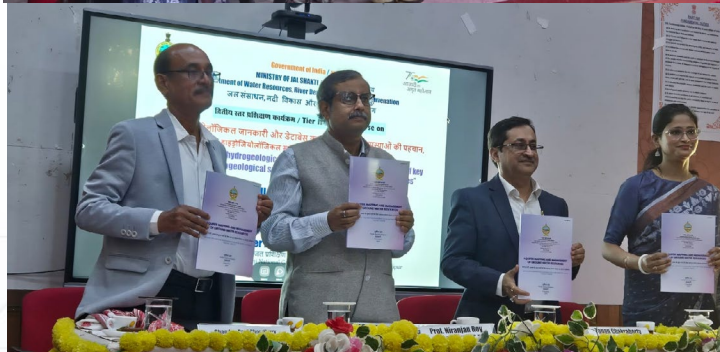

ABOUT THE DEPARTMENT

The Department of Mathematics, Gurucharan University, has been an integral part of the institution ever since the inception of the erstwhile Gurucharan College in 1935. It has a long tradition of maintaining a praiseworthy academic performance in the region. The department is continuing to march ahead maintaining the tradition and has produced many students who are shining in the field of mathematics and beyond. The department is actively involved in teaching as well as research. Apart from this, the department is playing a leading role in conducting mathematical olympiads at various levels to popularize mathematics. The department has received grants from various central government agencies like SERB (now ANRF), NBHM (National Board for Higher Mathematics) and HBCSE (Homi Bhabha Centre for Science Education) for research and other mathematical activities.

GENERAL INFORMATION FOR ADMISSION TO FIVE-YEAR INTEGRATED MASTER'S PROGRAMME (FYIMP) AND TWO-YEAR MASTER'S PROGRAMME

A. ADMISSION TO FYIMP AND TWO-YEAR MASTER'S PROGRAMME

- i. Application for admission into the university should be made in the prescribed Application Form through (assamadmission.samarth.ac.in) online mode only.
- ii. Notices prescribing the norms, date of counselling admission etc. will be available on the university's website.
- iii. The admission process is conducted under the supervision of the Admission Committee/s constituted for the purpose. There is a separate admission committee for each faculty (Faculty of Science, Faculty of Languages, Faculty of Humanities and Social Sciences, Faculty of Commerce and Management). Each committee will be guided by a common admission procedure.
- iv. The candidates have to submit separate admission forms for separate faculties.
- v. While filling up the forms for admission, an applicant should pay due attention in the matter of furnishing his/her preference for Combination he/she intends to take up.
- vi. Admission will be strictly on merit basis. It will be based on the marks obtained in the H.S./U.G. result, and will be governed by the university admission rules.
- vii. For admission into the FYIMP course, the marks of the best five (05) subjects will be considered, *and relevant departmental criteria, if any, will also be considered.*
- viii. For admission into the Two-Year Master's Programme, the percentage of marks scored in the relevant Honours/Core/Elective course will be considered. Grade points will be converted into percentage, where percentage of marks is not mentioned.
- ix. Any undue pressure or interference in the matter(s) of admission will be treated as disqualification amounting to forfeiture of claim for admission.
- x. The self-attested Xerox copies of the following documents are to be furnished along with application for admission:
 - Supporting documents to prove domicile of Assam, in case of candidates willing to avail reservation or Fee-waiver.
 - Mark Sheets and Certificates from H.S.L.C. onwards including all qualifying examinations.
 - Character Certificate from the institution last attended.
 - SC/ST/OBC/MOBC/EWS-Certificate issued by the competent authority from the state of Assam
 - Gap certificate in case the student passed the qualifying examination earlier than the current year.
 - Migration certificate for C.B.S.E. and outside State students.
 - Latest Passport size photograph for Identity card.
- xi. No request for admission will be entertained after the prescribed date fixed by the authority.

B. SOME IMPORTANT INSTRUCTIONS

- i. Submission of Registration form for FYIMP and Two-Year Master's Programme is compulsory.
- ii. Students are directed to go through the Notice Board/University Website regularly to acquire necessary information.
- iii. Guardians are requested to keep checking the local newspaper and college website for eligibility criteria, date of admission in FYIMP and Two-Year Master's Programme

C. CHANGE OF SUBJECT(S)/COMBINATION

In general, change of subject(s)/combination is not encouraged. Students should give proper thought in the matter before filling in their application form for admission.

- iii) Hostel Clearance Certificate. iv) Records of attendance duly signed by the respective Heads of the Departments. v) Surrender of the University Identity Card.

REGULATIONS FOR FIVE-YEAR INTEGRATED MASTER'S PROGRAMME (FYIMP)

[UG and PG PROGRAMME]

(Effective from Academic Session 2026-2027)

1. Short Title, Scope, Application and Commencement

- 1.1 These Regulations shall be called the Gurucharan University Regulations for the Five-Year Integrated Master's Programme (FYIMP).
- 1.2 These Regulations shall govern the academic structure, credit framework, curriculum design, assessment system, progression rules, exit provisions and award of degrees under the FYIMP offered by Gurucharan University, Silchar.
- 1.3 The FYIMP is designed in accordance with the National Education Policy (NEP) 2020 and guidelines issued by the University Grants Commission (UGC) from time to time.
- 1.4 These Regulations shall apply to all students admitted to the FYIMP Programme from the academic session notified by the University.
- 1.5 The interpretation of any clause of these Regulations shall rest with the University and its decision shall be final.
- 1.6 The University reserves the right to modify, amend or interpret these Regulations in conformity with directives issued by the University Grants Commission or Government (State and Central) from time to time.

2. Objectives of the Programme

- 2.1 The Five-Year Integrated Master's Programme (FYIMP) aims to provide a continuous and academically coherent pathway from undergraduate to master's/postgraduate level education.
- 2.2 The programme aims to ensure that students acquire:
 - Strong foundational knowledge in the discipline at undergraduate level.
 - Advanced and specialized knowledge during master's/postgraduate level.
 - Analytical, critical thinking and problem-solving skills.
 - Research competence and academic writing ability.
 - Professional, technical and interdisciplinary skills.
 - Ethical values and social responsibility.
- 2.3 The programme integrates classroom teaching, laboratory training, field work, seminars, skill-based learning and research training in a structured academic framework.

3. Duration and Structure

- 3.1 The FYIMP shall extend over five academic years comprising ten semesters.
- 3.2 Each semester shall ordinarily consist of 15–18 weeks of teaching, excluding examination period.
- 3.3 The minimum credit requirement for Integrated Programme (FYIMP) shall be 202 credits.

3.4 Students who discontinue at any stage may re-enter within three years, subject to credit validity, seat availability and University rules.

4. Credit Framework and Academic Workload

4.1 The University shall implement a Credit-Based Semester System (CBSS), wherein academic performance is measured in terms of credits earned.

4.2 A credit represents a quantified measure of academic engagement. The equivalence shall be:

- 1 Credit = 15 hours of classroom instruction (Theory)
- 1 Credit = 30 hours of Practical/Laboratory work
- 1 Credit = 30 hours of Internship, Fieldwork, Community Service, Project Work etc.

4.3 Each semester shall normally carry a minimum of 20 credits, ensuring balanced academic load and progressive accumulation of knowledge.

4.4 Credits shall be awarded only upon successful completion of course requirements and minimum passing criteria.

5. Multiple Entry and Exit Options

5.1 The Five-Year Integrated Master's Programme (FYIMP) shall follow the multiple entry and exit system in accordance with NEP-2020 (Table 1).

5.2 Students may exit at the stages mentioned above and may re-enter within the permitted maximum duration subject to University rules.

5.3 The credit distribution for various programmes under FYIMP is shown in Table 2.

5.4 Students shall be promoted to the seventh semester after completion of the sixth semester. However, all arrears up to the sixth semester must be cleared for such promotion.

5.5 A minimum CGPA of 7.5 at the end of Sixth Semester shall be required to opt for Honours with Research.

6. Structure and Components of the Curriculum

- 6.1 The curriculum of the Five-Year Integrated Master's Programme (FYIMP) shall be designed to provide a balanced combination of disciplinary depth, interdisciplinary exposure, skill development, and research orientation. The programme integrates undergraduate and postgraduate studies in a continuous academic framework spread over ten semesters.
- 6.2 The curriculum shall consist of the following academic components:
- Discipline Specific Core (DSC)
 - Discipline Specific Minor (DSM)
 - Multi-disciplinary Courses (MDC)
 - Ability Enhancement Courses (AEC)
 - Skill Enhancement Courses (SEC)
 - Value Added Courses (VAC)
 - Internship / Experiential Learning
 - Community Engagement
 - Research Project / Dissertation (RES)

- 6.3 The Discipline Specific Core (DSC) shall constitute the primary academic foundation of the programme. These courses shall provide in-depth knowledge, conceptual clarity, and advanced disciplinary understanding in the chosen field of study.
- 6.4 The Discipline Specific Minor (DSM) shall allow students to acquire complementary knowledge either within the discipline or in allied subject areas, thereby promoting academic flexibility and interdisciplinary competence.
- 6.5 Multi-disciplinary Courses (MDC) shall expose students to knowledge domains beyond their primary discipline, encouraging intellectual breadth and cross-disciplinary understanding in accordance with the principles of multidisciplinary education.
- 6.6 Ability Enhancement Courses (AEC) shall focus on developing essential competencies in a Modern Indian Language (MIL) and English by focusing on the communication skills needed for their professional and academic success. The MIL options includes Assamese, Bengali, Hindi, Hmar, Dimasa, Manipuri, Persian and Sanskrit. The distribution of AEC papers for Faculty of Science (FoS), Faculty of Languages (FoL), Faculty of Humanities and Social Sciences (FoH&SS) and Faculty of Commerce and Management (FoC&M) are given in table 3:

- 6.7 Skill Enhancement Courses (SEC) shall emphasize employability, vocational competence, entrepreneurship, digital literacy, and practical application of knowledge through hands-on learning and skill-based activities.
- 6.8 Value Added Courses (VAC) shall promote ethical values, constitutional awareness, Indian knowledge systems, environmental responsibility, and social consciousness among students. Table 4 shows the faculty-wise distribution of VAC paper.

- 6.9 Internship / Experiential Learning components shall provide opportunities for students to gain practical exposure through field-based training, industry interaction, vocational activities, or institutional internships, particularly during the early stages of the programme.
- 6.10 Community Engagement shall form an integral part of FYIMP programme. Students shall participate in socially relevant activities, outreach programmes, or field-based community initiatives. This component shall be compulsory and shall carry 2 credits.
- 6.11 The Research Project / Dissertation (RES) shall be undertaken during the fifth year of the programme. This component shall provide students with training in research methodology, independent investigation, academic writing, and presentation of research findings.
- 6.12 The detailed framework of the Five-Year Integrated Master's Programme (FYIMP) is given in Table 5, showing the distribution of courses and credits across different semesters.

7. Internship and Experiential Learning

- 7.1 Internship and experiential learning shall form an important component of FYIMP, aimed at providing students with practical exposure and application of theoretical knowledge in real-world settings.
- 7.2 Students shall undertake Internship / Apprenticeship / Vocational Training during the early stages of the programme to develop practical skills, industry exposure, and professional competencies relevant to their discipline.
- 7.3 A Summer Internship carrying 4 credits shall be mandatory for students seeking exit after the first year (Certificate) and second year (Diploma) of the programme.
- 7.4 The internship may be carried out in industries, research laboratories, academic institutions, government organizations, non-governmental organizations, community-based organizations, or other relevant institutions, subject to approval by the concerned Department.
- 7.5 The evaluation of the Internship shall be based on submission of an internship report, presentation, and/or viva voce, as prescribed by the Department or the Board of Studies.
- 7.6 Experiential learning components such as field work, laboratory work, project-based learning, community-based activities, and institutional visits may also be included as part of the curriculum to enhance practical learning and professional development.
- 7.7 The detailed guidelines regarding internship duration, evaluation, and reporting shall be prescribed by the concerned Department in accordance with the academic regulations of the University.

8. Research Project/ Dissertation

- 8.1 Students opting for the Honours with Research in the fourth year of UG Programme shall undertake a Dissertation carrying 12 credits in the in 4th Year of the UG programme.
- 8.2 A minimum CGPA of 7.5 at the end of Sixth Semester shall be required to opt for Honours with Research. The student must not have any arrear up to Sixth Semester..
- 8.3 In the 5th Year, the Research Project / Dissertation shall be a compulsory academic component of the Master's/Postgraduate stage (Semester IX and X) and shall carry 12 credits.
- 8.4 The objective of the dissertation is to provide students with training in research methodology, independent investigation, critical analysis, academic writing, and presentation of research findings.
- 8.5 The Dissertation shall involve identification of a research problem, review of literature, methodology, data analysis, interpretation and conclusion.

- 8.6 The Research Project / Dissertation shall be carried out under the supervision of a faculty member of the concerned Department. The topic of the dissertation shall be approved by the Departmental Affairs Committee.
- 8.7 The Dissertation shall be completed in two stages as shown in Table 6.

- 8.8 A mid-semester progress Seminar for RES 401 and RES 601 may be organised by the Department.
- 8.9 The evaluation of Final Dissertation (RES 451 and RES 651) includes Dissertation report, Presentation and/or Viva Voce, which will be conducted by a Board consisting of Supervisor, one External Expert from within the University, and Head of the Department. The evaluation pattern of Dissertation is shown in Table 7.

- 8.10 All research work must follow academic and ethical standards prescribed by the University. Any cases of plagiarism or academic misconduct shall be dealt with strictly in accordance with the University Research Ethics and Plagiarism Regulations.

9. Attendance Requirement

- 9.1 A student must maintain a minimum of 75% attendance in each course.
- 9.2 Attendance of students in each course shall be recorded by the concerned teacher and monitored by the Head of the Department. The consolidated attendance statement shall be verified before submission of examination forms.

- 9.3 A shortage of attendance may be condoned by the competent authority in genuine cases such as illness, medical emergency, or other unavoidable circumstances, subject to submission of valid supporting documents.
- 9.4 Students representing the University in academic, research, co-curricular, or extension activities such as seminars, workshops, conferences, symposia, youth festivals, sports events, cultural competitions, NSS, NCC, community engagement programmes, field work, or similar officially approved activities shall be eligible for attendance relaxation for the period of such participation, provided that:
- Prior written permission is obtained from the Head of the Department/Registrar;
 - The participation is duly certified by the organizing authority;
 - The total relaxation granted remains within the limits prescribed by the University.
 - Attendance of the student participating in such programmes/events shall be recorded by the concerned Department.
- 9.5 Participation in officially approved research work, dissertation-related field visits, laboratory work, institutional visits, or extension activities conducted under the supervision of the Department shall be recorded as attendance for the relevant period.
- 9.6 The decision of the competent authority regarding grant or refusal of attendance condonation shall be final.

10. Assessment and Examination

- 10.1 Evaluation of students in FYIMP shall consist of Continuous Internal Assessment (CIA) and End Semester Examination (ESE).
- 10.2 Continuous Internal Assessment may include internal assessment, attendance and practicum components.
- 10.3 Practicum or Experiential learning component may include Practical, Tutorial, Field work, Project work, Home assignments, Group discussion, Seminar, Quiz, Presentation, Studio activities, Community service, MCQ, Short test etc.
- 10.4 The assessment and examination pattern shall follow the evaluation framework prescribed under the FYIMP Regulations of the University (Table 8).

- 10.5 The Skill Enhancement Courses (SEC 601 and SEC 651) shall carry 4 credits each, and shall be covered in the final year of the Five-Year Integrated Master's Programme.
- 10.6 The Dissertation shall be evaluated separately in accordance with the provisions prescribed under Section 8 of this Regulation.

11. Grading System

- 11.1 The University shall adopt a 10-point grading scale for evaluating the performance of students in the Five-Year Integrated Master's Programme (FYIMP). The grades and corresponding grade points are shown in Table 9.

- 11.2 The Semester Grade Point Average (SGPA) and Cumulative Grade Point Average (CGPA) shall be calculated on the basis of the credit-weighted grade point system.
- 11.3 The Cumulative Grade Point Average (CGPA) shall be calculated in a similar manner by taking into account the grade points obtained in all courses completed across all semesters of the programme.

SGPA (Semester Grade Point Average)

$$\text{SGPA (Si)} = \frac{\sum C_i G_i}{\sum C_i}$$

Where:

C_i = Number of credits for the i^{th} course

G_i = Grade point obtained in the i^{th} course

The SGPA represents the ratio of the sum of the product of the number of credits with the grade points secured by a student in all the courses taken in a semester and the sum of the credits of all courses registered in that semester.

11.4 The Cumulative Grade Point Average (CGPA) shall be calculated in a similar manner by taking into account the grade points obtained in all courses completed across all semesters of the programme.

CGPA (Cumulative Grade Point Average)

$$CGPA = \frac{\sum C_i S_i}{\sum C_i}$$

Where:

C_i = Credits assigned to the i^{th} semester

S_i = SGPA obtained in the i^{th} semester

11.5 The SGPA and CGPA shall be rounded off to two decimal places and shall be indicated in the Grade Sheet / Transcript issued by the University.

11.6 The conversion of CGPA into percentage of marks shall be done using the following formula:

$$\text{Percentage of Marks} = \text{CGPA} \times 10$$

12. Promotion and Backlog Rules

12.1 A student shall be promoted to the next semester upon completion of the prescribed academic requirements and subject to the applicable backlog rules of the University.

12.2 Students who fail to secure the minimum prescribed passing marks in any course shall be permitted to reappear in the next corresponding Odd/Even End Semester Examination for that course in accordance with the examination regulations of the University.

12.3 A student may carry forward backlog courses to subsequent semesters, subject to the maximum permissible limit and conditions prescribed by the University from time to time.

12.4 All credits required for the completion of the Five-Year Integrated Master's Programme (FYIMP) must be earned within the maximum duration, as prescribed by the University.

12.5 Students shall be eligible for multiple exit options after completion of the prescribed credits at different stages of the programme in accordance with the prescribed Regulations.

13. Award of Degree

13.1 Upon successful completion of prescribed credits and fulfilment of academic requirements, the University shall confer Certificate, Diploma, Bachelor's Degree, Bachelor's Degree (Honours/Honours with Research) or Master's/Postgraduate Degree.

13.2 A student on successful completion of the Fifth Year (Semesters IX and X) and after securing the requisite 202 credits, shall be awarded the Master's/Postgraduate Degree (in the field of study/discipline) under the Five-Year Integrated Master's Programme (FYIMP), in accordance with the provisions of the University Regulations.

REGULATIONS FOR TWO-YEAR MASTER'S PROGRAMME

(Effective from Academic Session 2026-2027)

1. Short Title, Scope and Commencement

- 1.1 These Regulations shall be called the Gurucharan University Regulations for the Two-Year Master's Programme.
- 1.2 These Regulations shall govern the academic structure, credit framework, curriculum design, assessment pattern, research component, progression rules, exit provisions and award of Master's/Postgraduate Degree offered by Gurucharan University, Silchar.
- 1.3 These Regulations shall apply to all students admitted to Master's Programmes from the academic session notified by the University.
- 1.4 These Regulations are framed in conformity with the policy framework prescribed by the University Grants Commission under the National Education Policy 2020 and other guidelines issued from time to time.
- 1.5 The interpretation of any clause of these Regulations shall rest with the University, whose decision shall be final and binding.
- 1.6 The University reserves the right to amend, modify or repeal any provision of these Regulations in accordance with statutory requirements.

2. Objectives of the Programme

- 2.1 The Two-Year Master's Programme is designed to provide advanced and specialized education in the chosen discipline, emphasising on academic rigour, intellectual and research-oriented learning within a structured and outcome-based framework.
- 2.2 The programme aims to ensure that students acquire:
 - In-depth and specialized knowledge in core and emerging areas of the discipline.
 - Advanced analytical, critical thinking and problem-solving abilities.
 - Competence in research methodology, data analysis and academic writing.
 - Professional and technical skills relevant to industry, academia and public institutions.
 - Ethical values, academic integrity and social responsibility in professional practice.
- 2.3 The programme integrates classroom learning with practical training, laboratory work, seminars, case analysis, field-based activities and structured dissertation work to strengthen applied knowledge and independent inquiry.
- 2.4 The curriculum is structured to prepare students for doctoral studies, research careers, professional employment, public service, entrepreneurship and leadership roles in their respective fields.

3. Duration and Structure

- 3.1 The Two-Year Master's Programme shall ordinarily extend over two academic years comprising four semesters.
- 3.2 Each semester shall ordinarily consist of 15–18 weeks of teaching, exclusive of examination period.
- 3.3 The duration of the Two-Year Master's Programme shall depend upon the entry qualification of the candidate, as follows:

(a) Entry after completion of Three-Year Bachelor's Degree

- Candidates who have successfully completed Three-Year Bachelor's Degree shall be admitted to Semester I of the Two-year Master's Programme.
- They may exit after completion of one year (two semesters) with a Post Graduate Diploma, upon earning 42 credits.
- They shall be awarded the Master's/Postgraduate Degree upon successful completion of four semesters and earning 82 credits.

(b) Lateral Entry after completion of Four-Year Bachelor's Degree/ FYUG Programme

- Candidates who have successfully completed Four-Year Bachelor's Degree (Honours / Honours with Research) in the relevant discipline may be eligible for admission into Semester III/ Second Year of the Master's Programme, subject to University admission regulations and fulfilment of eligibility criteria.
- Such candidates shall complete Semesters III and IV of Post Graduate Programme, and earn 40 credits for award of the Master's/Postgraduate Degree.

3.4 The maximum permissible duration for completion of the Master's Degree shall be:

- Four (4) years from the date of admission for candidates entering in Semester I/ First Year.
- Two (2) years from the date of admission for candidates entering directly into Semester III/ Second Year.

3.5 Students who discontinue the programme may re-enter within the maximum permissible duration, subject to validity of earned credits, availability of seats and approval of the University. Such re-entry requires University approval and must comply with current admission regulations and eligibility criteria.

4. Credit Framework and Academic Workload

4.1 The University shall implement the Credit-Based Semester System (CBSS) for all Master's Programmes, wherein academic performance is measured in terms of credits earned.

4.2 A credit represents a quantified measure of academic engagement. The equivalence shall be:

- 1 Credit = 15 hours of classroom instruction (Theory)
- 1 Credit = 30 hours of Practical / Laboratory work
- 1 Credit = 30 hours of Fieldwork, Internship, Project Work or Dissertation-related activity

4.3 Each semester shall normally carry a minimum of 20 credits, ensuring balanced academic workload and progressive academic advancement.

4.4 Credits shall be awarded only upon successful completion of prescribed course requirements and fulfilment of minimum passing criteria.

4.5 A student must earn:

- 42 credits for award of a Postgraduate Diploma (Exit after one year), and
- 82 credits for award of a Master's Degree.

5. Structure and Components of the Curriculum

5.1 The curriculum shall be composed of the following academic categories:

- Discipline Specific Core (DSC)
- Discipline Specific Elective (DSE)
- Skill Enhancement Courses (SEC)

- Research Methodology
 - Practical / Laboratory Courses
 - Dissertation / Research Project (RES)
- 5.2 The Discipline Specific Core (DSC) courses shall form the principal academic component of the programme and shall ensure advanced and specialized knowledge in the chosen discipline.
- 5.3 Discipline Specific Elective (DSE) courses shall provide opportunities for specialization, interdisciplinary learning, or exposure to emerging areas within the discipline.
- 5.4 Skill Enhancement Courses (SEC) shall focus on advanced professional competencies, research tools, digital applications, data analysis, academic writing, and domain-specific technical skills.
- 5.5 Research Methodology shall equip students with knowledge of research design, quantitative and qualitative methods, data interpretation, academic ethics, and scholarly communication.
- 5.6 Dissertation / Research Project (RES) shall constitute a mandatory component for award of the Master's/Postgraduate Degree and shall involve independent research under the supervision of a faculty member.
- 5.7 Internship or field-based training may be incorporated where prescribed by the concerned Department.
- 5.8 The framework of the Two-Year Master's Programme with various course components and credit distribution is shown in Table 1.

6. Credit Distribution

- 6.1 The Two-Year Master's Programme of Gurucharan University, Silchar, shall require a minimum of 82 credits for the award of the Master's/Postgraduate Degree and 42 credits for the award of the Postgraduate Diploma.
- 6.2 The credit distribution for different entry pathways shall be as prescribed in Table 2.

- 6.3 The credit requirement based on the entry mode is as follows:
- (a) Candidates admitted after completing Three-Year Bachelor's Degree:
- Shall complete four semesters (82 credits) for the award of a Master's/Postgraduate Degree.
 - May exit after two semesters (42 credits) for the award of a Postgraduate Diploma.
- (b) Candidates admitted after Four-Year Bachelor's Degree, i.e., FYUG (Honours / Honours with Research):
- Shall be eligible for direct admission into Semester III/ Second Year of Two-Year Master's Programme.
 - Shall complete Semesters III and IV (40 credits) including Dissertation components for the award of a Master's/Postgraduate Degree.
- 6.4 The Research component (Dissertation) of the Two-Year Master's Programme shall consist of Research Proposal (4 credits) in Semester III and Final Dissertation (8 credits) in Semester IV, which shall be mandatory for award of the Master's/Postgraduate Degree.
- 6.5 Community Engagement in Semester II shall be mandatory. It will be of 2 credits (100 marks), with 75 marks for report writing and 25 marks for assessment based on experiential learning.
- 6.6 Internship shall not be mandatory for the award of the Postgraduate Diploma or Master's/Postgraduate Degree, unless specifically prescribed by the concerned Board of Studies for a particular discipline.

7. Research Project / Dissertation

- 7.1 The Research Project / Dissertation (RES) shall be a compulsory component of the Master's/Postgraduate Degree Programme. Students exiting after Semester II for the award of Postgraduate Diploma are not required to undertake a Dissertation.
- 7.2 The Research Project / Dissertation shall carry 12 credits, distributed across Semester III and Semester IV.

- 7.3 The Dissertation shall involve identification of a research problem, review of literature, methodology, data analysis, interpretation and conclusion.
- 7.4 The Research Project / Dissertation (RES) shall be carried out under the supervision of a faculty member of the concerned Department. The topic of the dissertation shall be approved by the Departmental Research Committee.
- 7.5 The Dissertation shall be completed in two stages as shown in Table 3.

- 7.6 Students shall submit a research proposal and make a seminar presentation during Semester III. The progress of the research work shall be monitored by the supervising teacher and the Department.
- 7.7 In Semester IV, a mid-semester progress Seminar for RES 651 shall be organised by the Department.
- 7.8 The evaluation of RES 651 includes Dissertation report, Presentation and/or Viva Voce, which will be conducted by a Board consisting of Supervisor, one External Expert from within the University, and Head of the Department. The evaluation pattern of RES 601 and RES 651 is shown in Table 4.

- 7.9 All research work must follow academic and ethical standards prescribed by the University. Any cases of plagiarism or academic misconduct shall be dealt with strictly in accordance with the Gurucharan University Research Ethics and Plagiarism Regulations.

8. Attendance Requirement

- 8.1 A student must maintain a minimum of 75% attendance in each course.
- 8.2 Attendance of students in each course shall be recorded by the concerned teacher and monitored by the Head of the Department. The consolidated attendance statement shall be verified before submission of examination forms.

- 8.3 A shortage of attendance may be condoned by the competent authority in genuine cases such as illness, medical emergency, or other unavoidable circumstances, subject to submission of valid supporting documents.
- 8.4 Students representing the University in academic, research, co-curricular, or extension activities such as seminars, workshops, conferences, symposia, youth festivals, sports events, cultural competitions, NSS, NCC, community engagement programmes, field work, or similar officially approved activities shall be eligible for attendance relaxation for the period of such participation, provided that:
- Prior written permission is obtained from the Head of the Department/Registrar;
 - The participation is duly certified by the organizing authority;
 - The total relaxation granted remains within the limits prescribed by the University.
 - Attendance of the student participating in such programmes/events shall be recorded by the concerned Department.
- 8.5 Participation in officially approved research work, dissertation-related field visits, laboratory work, institutional visits, or extension activities conducted under the supervision of the Department shall be recorded as attendance for the relevant period.
- 8.6 The decision of the competent authority regarding grant or refusal of attendance condonation shall be final.

9. Assessment and Examination

- 9.1 Evaluation of each course shall consist of Continuous Internal Assessment (CIA) and End Semester Examination (ESE).
- 9.2 Continuous Internal Assessment may include internal assessment, attendance and practicum components.
- 9.3 Continuous Internal Assessment may include session tests, assignments, seminars, attendance, laboratory performance, field work, project work, presentations, quizzes, skill demonstrations, and other academic engagement activities as prescribed by the Department.
- 9.4 The assessment and examination pattern shall follow the evaluation framework prescribed under the Five-Year Integrated Master's Programme (FYIMP) Regulations of the University.
- 9.5 The evaluation pattern for Discipline Specific Core (DSC) and Discipline Specific Elective (DSE) courses is presented in Table 5.

9.7 The Dissertation shall be evaluated separately in accordance with the provisions prescribed under Section 7 of this Regulation.

10. Grading System

10.1 The University shall adopt a 10-point grading scale (Table 7).

10.2 The Semester Grade Point Average (SGPA) and Cumulative Grade Point Average (CGPA) shall be calculated on the basis of the credit-weighted grade point system.

10.3 The Cumulative Grade Point Average (CGPA) shall be calculated in a similar manner by taking into account the grade points obtained in all courses completed across all semesters of the programme.

SGPA (Semester Grade Point Average)

$$SGPA (S_i) = \frac{\sum C_i G_i}{\sum C_i}$$

Where:

C_i = Number of credits for the i^{th} course

G_i = Grade point obtained in the i^{th} course

The SGPA represents the ratio of the sum of the product of the number of credits with the grade points secured by a student in all the courses taken in a semester and the sum of the credits of all courses registered in that semester.

- 10.4 The Cumulative Grade Point Average (CGPA) shall be calculated in a similar manner by taking into account the grade points obtained in all courses completed across all semesters of the programme.

CGPA (Cumulative Grade Point Average)

$$CGPA = \frac{\sum C_i S_i}{\sum C_i}$$

Where:

C_i = Credits assigned to the i^{th} semester

S_i = SGPA obtained in the i^{th} semester

- 10.5 The SGPA and CGPA shall be rounded off to two decimal places and shall be indicated in the Grade Sheet / Transcript issued by the University.
- 10.6 The conversion of CGPA into percentage of marks shall be done using the following formula:
Percentage of Marks = $CGPA \times 10$

11. Promotion and Backlog Rules

- 11.1 A student shall be promoted to the next semester upon completion of the prescribed academic requirements and in accordance with the backlog rules of the University.
- 11.2 A student failing in any course shall be permitted to reappear in the next corresponding Odd/Even End Semester Examination as per the University Examination Regulations.
- 11.3 Promotion from Semester I to II and Semester III to IV shall be allowed, subject to registration and compliance with requirements as laid down by University Rules
- 11.4 All prescribed credits must be earned within the maximum duration specified for completion of the Master's/Postgraduate Programme.
- 11.5 The Master's/Postgraduate Degree or Postgraduate Diploma shall not be awarded unless all credit requirements and other academic obligations, including Dissertation (where applicable), are successfully fulfilled.

12. Award of Degree

- 12.1 Upon successful completion of 42 credits after Semester II, a student shall be awarded the Postgraduate Diploma in the relevant discipline.
- 12.2 Upon successful completion of 82 credits (or 40 credits in case of lateral entry after Four-Year Undergraduate Degree) and fulfilment of all academic requirements, the University shall confer the Master's/Postgraduate Degree in the relevant discipline.
- 12.3 The nomenclature of the award shall reflect the discipline of study as approved by the competent statutory bodies of the University.

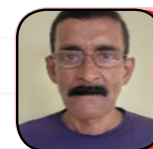

STUDENT SUPPORT AND WELFARE: CELLS AND BODIES

CAREER GUIDANCE CELL

The Career Guidance Cell of Gurucharan University aims to provide students with appropriate guidance to connect with the world of work and to identify career opportunities in line with emerging occupational trends and job profiles in a highly competitive global environment. The Cell actively liaises with recruiting agencies and HR professionals to conduct placement drives and campus interviews, enabling a significant number of students to secure employment. It also supports students in developing soft skills to help them effectively face competitive examinations and professional challenges. In addition, the Cell regularly organises seminars and workshops to familiarise students with emerging career trends, job opportunities, leadership roles, entrepreneurship, and market requirements.

EXTENSION SERVICE CELL

The Extension Service Cell operates a coaching centre in a slum area, providing academic support and basic study materials such as notebooks, pencils, erasers, pencil boxes, umbrellas, and school bags to students. Yoga classes are also conducted for the students as part of its outreach activities. In January 2016, the Cell organised a free eye camp at the Itkhola Ghat slum area, where 478 patients were examined and provided with free medicines. Twenty patients diagnosed with cataract were referred for free surgery, which was carried out through the Ramakrishna Mission Sevashrama, Silchar. In addition, 60 patients were provided with free spectacles after proper medical examination.

UNIVERSITY ENVIRONMENT CELL

University Environment Cell under Assam Science Technology and Environment Council (ASTEC) was established at Gurucharan University, Silchar from the Session 2018-2019. It works mainly for environment education, clean environment and Biodiversity conservation.

MENTAL HEALTH CELL

THE BIRD WATCHING CLUB

The Bird Watching Club of Gurucharan University, initiated by Dr. Debipreeta Dutta, Department of Zoology, has been actively functioning for the past six (06) years with the objective of promoting ecological awareness and encouraging field-based learning among students. The club provides a platform for systematic observation, identification, and documentation of avian diversity within and around the University campus.

Regular bird watching sessions are conducted in the campus and its adjoining areas, utilizing the natural habitat as a field laboratory. Although the activities are primarily organized by the Department of Zoology, students from all other faculties are also encouraged to participate, thereby fostering interdisciplinary engagement and environmental awareness across the institution.

A significant component of the club's activities is the systematic recording and uploading of bird sighting data on the eBird platform. This sustained effort has enabled active participation in global citizen science initiatives, helping students gain practical knowledge on biodiversity documentation, species distribution, and seasonal variations.

The club has consistently participated in annual national-level bird count events, contributing valuable data to large-scale biodiversity monitoring programmes. In recognition of these continuous efforts, the University campus has been identified as a hotspot for birding, reflecting its rich avifaunal diversity and ecological significance.

6. Computerization:

Library having Local Area Network (LAN)with 16 computers with Server. Complete database of books is available through OPAC. Automation is completed with SOUL software provided by INFLIBNET Center, Ahmedabad.

7. Library Sections:

A) Stack section: Here, the main collection of the University in the form of Text Books is kept. The number of books is nearly 42,905 at present. Due to open access system, students and teachers are free to visit the stack area to select their own choice.

B) Reference Section: Here, the rare and valuable collection is kept as reference source. Nearly 4000-volumes of valuable books are there for use by various categories of users like renowned personalities, resource persons, research scholars and university and University students.

C) Manuscript Section: This is a new feather to the University library which was developed during 2004-05. In 1995, the Manuscript Section was designated as Manuscript Resource Centre (MRC) by the National Mission for Manuscript (Now under IGNCA), Ministry of Culture, Govt. of India. This MRC covers 12 districts of Assam for manuscripts survey, documentation and preservation. In 2010, a Manuscript Conservation Centre (MCC) was also established in collaboration with the same Ministry of which activities are already started.

D) Periodical Section: This section contains almost 36 periodicals ranging from research level, career opportunities and popular magazine.

E) Newspaper Section: This section houses 7 nos. of newspaper.

F) Digital Library Section: The Library has a digital library with techfocuz digital Library Software.

G) UGC-Network Resource Centre: Under this centre, coordination of various activities, programmes, schemes, notices, etc, sponsored by UGC are looked after besides providing Internet services to teachers and students.

H) EDUSAT National Network Centre: The EDUSAT National Network Centre, which has been developed in collaboration with the Consortium of Educational Communication, New Delhi, is presently active in the University library, through which national educational programmes telecast by CEC, UGC, ISRO, IGNOU are available not only for viewing but one can also participate in the discussions live through phone or by web camera.

i) UGC-Infonet Digital Library Consortium: The University library has been selected for the UGC Infonet Digital Library Consortium, a programme which is sponsored by the UGC under INFLIBNET Centre, Ahmedabad. Though activities are pending yet, when it will get activated. library users will be able to browse and download approximately 4600 periodicals, national and international, in the library. The Gurucharan University library is amongst other 50 Universities of all over India to get selected for such programme.

- ii) Hostel seats are allotted strictly on the basis of merit of the students by the Hostel Committee set up for the purpose.
- iii) A few seats are reserved for SC/ST candidates.
- iv) Mere admission into the University does not confer any right to Hostel accommodation.
- v) The admission into the Hostel and conduct of the boarder is governed by the Hostel rules and regulations. The violation of rules will make a boarder liable to punitive measures to the extent of expulsion from the Hostel and the University.
- vi) Hostels remain closed during Summer and Puja vacations.

In the coming years, the scope of CIC will be extended further to provide the instruments having multi-disciplinary utilities to all the researchers.

BOTANICAL GARDEN

GYMNASIUM

The Language Lab has been operational since the 2017-18 academic session.

BIOTECH HUB / BIOINFORMATICS CENTRE

The Institutional Biotech Hub, sponsored by the Department of Biotechnology (DBT), commenced its activities at Gurucharan University in November 2011. The Hub was established to provide essential infrastructure and facilities in the field of Biotechnology for students, faculty members, and researchers of the University as well as neighboring institutions. The primary objective of the programme is to promote education and research in Biology, Life Sciences, and Biotechnology, while encouraging students to pursue careers in various areas of Biological Sciences and Biotechnology. The Bioinformatics Centre aims to support and facilitate biotechnology-related academic and research activities across institutions in North East India.

YOGA TRAINING & CERTIFICATION PROGRAMME



The Yoga Training and Certification Programme is conducted by Gurucharan University in association with NIRAMAYA. The programme is affiliated with the Indian Yoga Association and PIYSR, a leading yoga institution recognized by the Yoga Certification Board (YCB), Government of India, and Yoga Alliance/International Association of Yoga Therapists (IAYT), USA. It is also affiliated with Mudra Yoga Certification under the AYUSH Ministry, Government of India.

The programme offers students an opportunity to enhance their physical, mental, and emotional well-being through systematic yoga training. Conducted by experienced and certified yoga instructors, the course includes various yoga postures, breathing techniques, meditation practices, and holistic wellness exercises.

EXAMINATION CENTRE OF INSTITUTE OF CHARTERED ACCOUNTANTS

Gurucharan University is an official examination centre since 2020 of the Institute of Chartered Accountants of India. Since then, candidates from the Barak Valley and the southern region of North East India have been able to appear for Chartered Accountancy examinations at this centre. The University examination centre conducts examinations for the CA Foundation, Intermediate, and Final courses under the Institute.

Keeping in pace with the development of information and technology, Gurucharan University has established a Central Computer Lab with 29 computers with internet and other modern facilities for students.

Dress Code for Boys:

- SHIRT** : Sandal colour, full sleeves or half sleeves. One frontal pocket on which the university logo is to be stitched.
- TROUSER** : Coffee colour, with two side-pocket and one right back pocket, no bottom fold.
- SHOES** : Black leather with maximum elevation-1.25 inches.
- SOCKS** : Coffee colour, plain.
- BELT** : 1.25 inches, plain and simple.
- SWEATER** : Coffee colour, plain, front closed 'V' neck. Sleeveless or full sleeves.



Dress Code for Girls:

- KAMEEZ** : Sandal colour, close round neck, full sleeves or half sleeves with the university logo to be stitched on the left sleeve above the elbow level, knee length with 10 to 12 inches side-cut (Bottom)
- CHUNNI** : Coffee colour V-Shape with 6 inch pleats.
- SALWAR** : Coffee colour
- SHOES** : Black footwear with maximum elevation - 2 inches.
- SOCKS** : Coffee colour (Optional).
- SWEATER** : Coffee colour, front open 'V' neck, sleeveless or full sleeves.
