NOTICE REGARDING SPOT ADMISSION FOR FYIMP PROGRAMMES
(ACADEMIC SESSION 2026-2027)

In continuation of the Admission Notices issued earlier and consequent upon the completion of the First and Second Merit Round admissions, it is hereby notified that Spot Admission for the vacant seats under the Five-Year Integrated Master's Programmes (FYIMP) of Gurucharan University, Silchar will be conducted from 15th to 17th June 2026 for eligible Non-CUET candidates, subject to the availability of seats.

Candidates seeking admission through the Spot Round are advised to carefully read the eligibility criteria, admission procedure and other instructions provided below and ensure compliance with all requirements for the smooth completion of admission formalities.

GUIDELINES FOR SPOT ADMISSION 2026

1. The Spot Round Admission for **Non-CUET candidates** will be conducted from **15th to 17th June 2026** against the vacant seats remaining after the completion of the 1st and 2nd Merit Round admissions. The detailed vacancy status will be published on the University website on **13th June 2026**.
2. Only those candidates who are duly registered in the Assam State Higher Education Admission Portal (SAMARTH) shall be eligible to participate in the Spot Admission process. Candidates who have not applied earlier may submit fresh applications through the **SAMARTH Portal**. Those who had already applied but could not secure admission must re-submit their applications for consideration in the Spot Round. Candidates are advised to apply for multiple eligible programmes based on the vacancy position published on the **University website** to improve their chances of admission.
3. Submission of application through the SAMARTH Portal shall not by itself confer any claim for consideration under a particular day of Spot Admission. Candidates shall be considered only upon submission of the hard copy of the application to the concerned department within the prescribed time schedule. A hard copy of the submitted application form, along with self-attested photocopies of mark sheets and relevant certificates, must be submitted to the concerned department.

- Candidates must be physically present in the respective department with all original documents for verification during the Spot Admission process. Failure to produce the original documents at the time of verification shall lead to cancellation of candidature.
- The **Government Fee Waiver Scheme** will be applicable for Spot Round admissions, subject to the candidate fulfilling the eligibility criteria and successful verification through the SAMARTH system.
- Each department will receive the hard copies of applications up to **12:00 Noon** on each day of spot admission, i.e., **15th, 16th and 17th June 2026**. Based on the hard copy of the applications received, each department will prepare a merit list against the available vacant seats. Admission will be granted in accordance with the reservation policies of the **Government of Assam** and the **Government of India**. The PwD candidates will be selected in accordance with the government rules. The merit list will be displayed in the departmental notice board at 01.00 PM each day based on the vacant seats available, if any.
- The selected candidates have to complete their admission process on the same day after the publication of the departmental merit list. The admission process will be conducted from **2:00 PM to 4:30 PM** on **15th, 16th and 17th June 2026**. Counselling and admission formalities will be carried out by the respective departments.
- Mere submission of application shall not confer any right to admission. Admission shall be strictly on merit and subject to availability of seats.

FEE WAIVER SCHEME CANDIDATES

- Candidates seeking admission under the Fee Waiver Scheme shall be scrutinized by the competent authority on the basis of the prescribed eligibility criteria and supporting documents.
- Candidates found eligible under the Fee Waiver Scheme shall be granted admission provisionally and shall not be required to proceed for payment of admission fees. Such candidates may leave the venue after completion of departmental counselling and document verification formalities, subject to further approval by the University wherever necessary.

CANDIDATES UNDER PAID ADMISSION CATEGORY

- Candidates not covered under the Fee Waiver Scheme shall, after completion of departmental verification and counselling, proceed to the designated Admission Payment Counters located at the ground floor of **New Commerce Building (RUSA Building; adjacent to the Department of Commerce)** for payment of admission fees.
- It may be noted that payment of admission fees shall be accepted only at the designated University payment counters established for this purpose.
- No Department, Office, employee, student volunteer or any other person is authorized to collect admission fees on behalf of the University. The University shall not be responsible for any payment made at any unauthorized location or through any unauthorized person.

MODE OF PAYMENT

Admission fees shall be accepted **STRICTLY THROUGH ONLINE MODE ONLY**.

Students may make payment through:

- UPI/QR Code
- Debit Card
- Credit Card
- Net Banking
- Other authorized digital payment facilities provided by the University

Cash payment, cheque, demand draft or any other offline mode of payment shall not be accepted under any circumstances.

Candidates are therefore advised to carry a mobile phone, bank card or other appropriate means to facilitate digital payment on the day of admission.

IMPORTANT INSTRUCTIONS

1. Admission shall be purely provisional until verification of all documents and fulfilment of eligibility conditions.
2. Any discrepancy, suppression of facts or submission of false documents shall result in cancellation of admission at any stage.
3. Reserved category candidates must produce valid supporting documents in original.
4. Candidates must remain present personally during counselling and admission formalities.
5. All admissions shall be governed by the applicable rules, regulations and guidelines of the Government of Assam, DHE Assam and Gurucharan University.
6. Mere submission of an application or appearance in the Spot Admission process shall not confer any right to admission. Admission shall be strictly on merit, reservation policy and availability of vacant seats.
7. Refund of admission fees shall be processed only after completion of the entire admission process, in accordance with Government norms and DHE guidelines. Refund and cancellation of admission shall be allowed only within the timeline prescribed by the Directorate of Higher Education (DHE), Assam.
8. Candidates are advised to keep themselves updated by regularly visiting the official website of Gurucharan University, Silchar.

All concerned candidates and guardians are requested to adhere strictly to the above instructions for smooth and timely completion of the admission process.
