**No. BB.E.645843/03:** The Governor of Assam is pleased to notify the formulation of following guidelines in respect of the Flagship Scheme “**Year of Books**” announced at Para XI, Point No. 88 of the Finance Minister’s Budget Speech for the FY 2025-26.

1. All regular Government employees will be provided a one-time grant of Rs.1,000/- each for purchase of book.
2. Necessary budget provision has been made under the Head of Account- “2235-60-200-0406-016-32-01-SOPD-G” of Grant No. 25- Finance Department for this purpose.
3. For smooth drawal of fund, this Head of Account has been made **Global Head** and all Drawing and Disbursing Officers will have access to it without insisting for budget allotment.
4. Employees will submit vouchers to respective DDOs against procurement of books and thereafter, DDOs will prepare and submit bills to Treasuries for payment of the same after issue of necessary Financial Sanction from the competent authority .
