FOR ADMISSION OF REGULAR STUDENT'S INTO H. S. 2ND YEAR CLASSES FOR THE ACADEMIC SESSION 2026 – 2027.

In continuation of the earlier Notice dated 06/07/2026, it is hereby notified for the information of all concerned students who have not yet uploaded their admission forms for admission into **H. S. 2nd Year Classes** that they must upload the same on **13/07/2026** and report to **Counter No. 04** positively on or before **15/07/2026** for necessary verification of their admission forms.

Thereafter, the requisite admission fees are to be paid through **Counter Nos. 01, 02 & 03 (QR Code Payment)**, as per the following schedule:

Students applying under the **Fee Waiver Scheme** must report to **Counter No. 05** on **13/07/2026 and 15/07/2026** between **11:30 a.m. and 2:30 p.m.** with the following documents for submission, verification, and uploading of their details in the University system. Failure to comply within the stipulated period shall result in rejection of their claim, and no further request will be entertained.

Only those students who were admitted under the Fee Waiver Scheme in H. S. 1st Year (Academic Session 2025 – 2026) shall be eligible to avail themselves of the Fee Waiver Scheme for H. S. 2nd Year admission.

3. Declaration/Undertaking duly signed by the student.
